Resolution 23-06 – City of Colfax Water System Plan-

Ryan Rehder from Mountain Waterworks now Merrick, presented to the Public Works Committee in great detail the updated water system plan. Tonight will be a shortened presentation. The idea of that workshop was to identify priority capital improvements and discuss the financial side of the water system. The purpose of this document is to serve as a tool for the city council to make decisions on the water system over the next 20 years. Rehder distributed a map of Colfax that has colored line segments that represents water lines and major water facilities.

Rehder stated there are three primary objectives for the capital improvement needs for the city.

- 1) Replace and/or rehabilitate aging infrastructure
- 2) Improve fireflow
- 3) Increase operational flexibility and redundancy
